Union Congregational Church Elk River, MN Church Council Minutes Thursday, November 2, 2017

Meeting was called to order at 6:45 pm

- 1. Opening activity and prayer
- 2. Call meeting to order Patti Kubicka called to order at 6:45
- 3. Review and approve minutes from October 2017 Council meeting Three changes recommended. Joyce motion, Diane second to approve with modifications.
- 4. Consensus and voting
 - a. Patti proposed a Consensus and Voting bylaw. Diane asked if tonight's attendance would be consensus. We have four teams represented and need three for a consensus, so it would be enough. Patti would be tie breaker if the situation arose.
 - b. Joan asked why we don't have as good of attendance as in the past. Robin thinks it is because work is being done at the various teams/committees.
 - c. Patti asked if Diaconate has a Council rep at their meeting. Robin said they do, Marce Ediger. There was additional discussion about Diaconate needing representation the Council meeting. Robin suggested someone (other than her) needs to tell them they need someone here if Marce can't make it.
 - d. Discussion moved to who should be voting representatives on Council.
 - i. It was suggested the pastor have a vote, but Robin said she's never been in a church where she's had a Council vote.
 - ii. Robin suggested the At Large members also be the Denominational Delegates.

 During a previous discussion, the decision was only one of the two would have a vote if both were present. Robin asked, if we have two At Large delegates, should they both get a vote? If not, why not? If there was only one vote for two people, what if they had opposite positions? Gigi suggested to rotate every other month who votes. Other options were flip a coin or, if they don't agree, abstain. Patti suggested tabling. We have until May to finalize.
